A BILL

To amend the Oil Pollution Act of 1990 to permit funds in the Oil Spill Liability Trust to be used by the National Oceanic and Atmospheric Administration, the Coast Guard, and other Federal agencies for certain research, prevention, and response capabilities with respect to discharges of oil, for environmental studies, and for grant programs to communities affected by oils spills on the outer Continental Shelf, and to provide funding for such uses.

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Resources for Oil Spill
3 Research and Prevention Act”.

4 **SEC. 2. OIL SPILL LIABILITY TRUST FUND.**

5 (a) OIL SPILL LIABILITY TRUST FUND FINANCING
6 RATE.—

7 (1) IN GENERAL.—Subparagraph (B) of section
8 4611(c)(2) of the Internal Revenue Code of 1986 is
9 amended by inserting “except as provided in para-
10 graph (3)” before “the Oil Spill Liability Trust
11 Fund financing rate”.

12 (2) ADDITIONAL RATE ON CRUDE OIL.—Para-
13 graph (2) of section 4611(c) of the Internal Revenue
14 Code of 1986 is amended by adding at the end the
15 following new paragraph:

16 “(3) ADDITIONAL RATE ON CRUDE OIL.—In the
17 case of crude oil on which a tax is imposed under
18 subsection (a)(1) or (b), the Oil Spill Liability Trust
19 Fund financing rate under paragraph (2)(B) shall
20 be increased by—

21 “(A) in the case of domestic crude oil, 3
22 cents a barrel, and

23 “(B) in the case of any other crude oil,
24 7cents a barrel.”.

25 (3) REPEAL OF TERMINATION.—Section 4611
26 of such Code is amended by striking subsection (f).

1 (4) **EFFECTIVE DATE.**—The amendments made
2 by this subsection shall take effect on the first day
3 of the first calendar quarter after the date of enact-
4 ment of this Act.

5 (b) **REFERENCE TO OIL POLLUTION ACT OF 1990.**—
6 Section 9509(g) of the Internal Revenue Code of 1986,
7 as redesignated by subsection (c), is amended by striking
8 “on the date of the enactment of this subsection” and in-
9 serting “on the date of the enactment of the Resources
10 for Oil Spill Research and Prevention Act”.

11 **SEC. 3. USES OF THE OIL SPILL LIABILITY TRUST FUND.**

12 Section 1012(a) of the Oil Pollution Act of 1990 (33
13 U.S.C. 2712(a)) is amended—

14 (1) in paragraph (5)(C), by striking “and” at
15 the end;

16 (2) in paragraph (6), by striking the period at
17 the end and inserting “; and”; and

18 (3) by adding at the end the following:

19 “(7) with respect to amounts in the Fund at-
20 tributable taxes received under section 4611(c)(3) of
21 the Internal Revenue Code of 1986—

22 “(A) the payment of costs incurred by the
23 National Oceanic and Atmospheric Administra-
24 tion, the Coast Guard, and other Federal agen-
25 cies in maintaining research, prevention, and

1 response capabilities with respect to discharges
2 of oil;

3 “(B) the payment of costs incurred in car-
4 rying out environmental assessment studies;
5 and

6 “(C) the provision of grants to affected
7 States, communities, institutions of higher edu-
8 cation, and other entities for use in carrying
9 out research relating to discharges of oil on the
10 outer Continental Shelf of the United States.”.
